R.J. O'Brien & Associates, LLC, and its affiliates (collectively, "R.J. O'Brien", "RJO"or "we" or "us") believe in respecting the privacy and security of your personal information. The following Privacy Policy explains how R.J. O'Brien collects, uses, shares, and protects your personal information. Please read this Privacy Policy carefully. This Privacy Policy is provided to you on behalf of RJO and addresses RJO's data collection, use and disclosure practices.

If your account was introduced to RJO by an independent introducing broker, agent or another Futures Commission Merchant, this privacy policy applies only to how your personal information is handled and protected by RJO, not how it is handled and protected by your independent introducing broker, agent or Futures Commission Merchant.

We do not disclose any nonpublic personal information about our clients, or former clients, to anyone except as permitted by law.

Collection of Personal Information

We collect your personally identifiable information or corporate identifiable information (in the event your account is held on behalf of a corporate entity) ("PII") and other information directly from you and automatically or indirectly from you as a result of your relationship with us or use of and access to our services, including but not limited to:

- · through your broker or agent;
- from third parties who provide consumer information or verify consumer relationship;
- from consumer or credit reporting services, regulatory information providers, or other similar entities;
- information regarding your usage, experience and engagement with certain software applications provided to you by us; and
- information obtained through information collective devices from a web server.

PII includes any information by which you can be personally identified and may include your name, address, age, date of birth, electronic mail address, occupation, employment information, telephone number, education, the kind of service provided to you, credit card number, and other similar information.

We may use the PII collected from you to verify your identity and establish and maintain your account, among other reasons. This information also helps us improve our services to you, customize your browsing experience, and inform you about additional products, services, or promotions that may be of interest to you.

You directly provide us with the majority of PII we collect. We may also collect additional PII as required by law which includes information required to assess your experience and risk tolerance. Depending on our relationship, you provide us with this information by submitting an inquiry form, completing an account application and related documentation, by sending us an e-mail, or by submitting information in response to an inquiry.

The information we collect indirectly from you includes information gathered through your interactions with our website. This information may include, Internet protocol ("**IP**") address, browser type, operating system, Internet service provider ("**ISP**"), and time stamps.

We, and our third-party service providers, use cookies to provide us with data we can use to improve your experience and to remember information that you have provided or choices you have made on the website, such as saving your logged-in status or site preferences. Cookies are small text files sent from Web servers that may be stored on your device. Cookies enable us to capture how you arrived at our site, when you return, which pages on our site you visit, and to recognize that you are already logged on when we receive a page request from your browser. We may link the information we store in Cookies to personally identifiable information you submit while on our site. Cookies do not contain account or password information.

Use and Disclosure of Your Information

We may use and/or share your information, including PII, for the following reasons:

- To contact you in response to your inquiries, comments, and suggestions;
- To contact you otherwise when necessary;
- For the specific purpose for which it was voluntarily provided;
- To complete any transactions you may perform with or through us;
- To be provided to R.J. O'Brien's third parties in connection with the legitimate business purposes of R.J. O'Brien or the website;
- To third parties, including service providers, affiliates, and other outside organizations, that assist
 us with preparing and processing orders and statements;
- As required or permitted by law or regulation, or as requested by government authorities, or for the protection of persons or property; and
- In connection with an acquisition, merger, restructuring, sale, or other transfer involving all or any portion of the business.

Confidentiality and Security

We restrict access to your PII to those employees or service providers who need to know that information in order to provide products or services to you. We maintain physical, electronic and procedural safeguards to guard your PII. However, due to the design of the internet, we cannot guarantee that communications between you and our servers will be free from unauthorized access by third parties. Furthermore, your individual broker or agent may be provided your PII.

Accessing, Modifying, and Correcting Personal Information

We strive to maintain the accuracy of any personal information collected from you. However, we must rely upon you to ensure that the information you provide to us is complete, accurate, and up-to-date, and to inform us of any changes. Please review all your information carefully before submitting it to us and notify us as soon as possible of any updates or corrections.

USA Patriot Act: Notice to Clients

RJO may generate or extract Aggregate Data out of any databases, and we may make use of such Aggregate Data for any purpose, at our discretion.
