

POWER OF ATTORNEY REVOCATION

As evidenced by the undersigned's signature below, the undersigned hereby revokes, subject to the terms herein, the previously executed Power of Attorney which appointed the Account Controller (as identified below) as the undersigned's attorney-in fact as provided therein. Notwithstanding anything to the contrary provided herein, the undersigned hereby agrees that RJO shall not be liable for, and Customer shall hold RJO harmless from, any and all losses, expenses, damages or other costs incurred by the undersigned related to or arising from this Revocation, including, but not limited to, (i) any action or inaction taken by the Account Controller, or (ii) any failure on the part of the undersigned to take action with respect to existing positions after this revocation is delivered.
