



INTENT TO TRADE CERTAIN EXCHANGES

Regulation (EU) No 600/2014 of May 14, 2014 ("MiFIR") became effective on January 3, 2018. This regulation requires firms like R.J. O'Brien & Associates, LLC ("RJO") to comply with new transaction reporting requirements related to clients who access and trade on exchanges in the European Union ("EU"). Additionally, similar requirements are also in place for clients who access and trade on the London Metal Exchange ("LME") and ICE Futures Europe.

RJO will only be able to facilitate EU, LME, and ICE Futures Europe transactions with counterparties which have provided the information requested below. Account types associated with natural persons will require information specific to their country of nationality, while account types associated with a legal entity will require a Legal Entity Identifier (LEI). Any individual who will execute trades for an entity will also be required to provide the same identifying information as an individual account owner. If applicable, please duplicate this page and provide the requested information for every individual who may trade an entity account.

*Please note that RJO requires a separate disclosure form that must be signed by clients that intend to trade LME.
Please note that RJO requires a separate attestation form that must be signed by clients that intend to trade ICE Endex.
